

## **1 Program and Options**

**infra - CONVERT** is a software program for creating quality control plans from 2D CAD drawings or graphics files. These files can be indexed with VDA stamps. The program can also be used to reproduce issued stamped drawings and individual features as graphics documents.

The software can be purchased with the following modules:

- Basic version:  
Processing DWG and DXF 2D-CAD format files
- Module IGES:  
additional processing of IGES 2D-CAD formats (\*.IGS, \*.IG2, \*.IGES)
- Modul GRAPHIC:  
Zu additional processing of graphic formats PDF, TIF, JPG, BMP, GIF and PNG

Note The modules can only be purchased with a basic version of the software.

## **2 Limits**

Software functionality is very dependent on the quality of the CAD information. Errors in the drawings or missing information can have a significant influence on software functionality. The ELIAS GmbH cannot be held liable for such shortcomings or the consequences thereof. AutoCAD version 2006, without additional applications, is used as a quality reference for DXF/DWG files.

In contrast to CAD files, graphic files processed with the module GRAPHIC are not able to automatically read or process features information. Such limitations are due to file format and not the responsibility of the ELIAS GmbH.

## **3 Licence models**

### **3.1 Single workstation licence**

The software may only be used at any one time on a single computer. A copy-protection system is installed on the computer and the software can only be used when this system is available.

### **3.2 Multiple licences**

For multiple licences (aka. floating licences), the number of active instances of the software may not exceed the number purchased. Licences are restricted to the site for which they were purchased and may not be used at other sites. A copy-protection system is installed on a central computer that must be accessible for all the designated workplaces.

All the licences in a multiple licence package must have the same modules.

## **4 Software protection**

The software is supplied with a copy-protection system. This uses a USB dongle containing the activated licence(s). Each single licence requires a dongle that needs to be installed on each workplace computer. A dongle is needed for multiple licences and is installed on a central PC or server, accessible via a network.

## **5 Maintenance contract**

A maintenance contract for the software can be purchased. The maintenance contract includes cover for the current version of **infra - CONVERT**, delivered with the options purchased, and support (telephone and email).


- The contract costs 1.25 % of the software licence purchased per month.
- The maintenance contract starts with installation of the software by the ELIAS GmbH or one of their partners (handover date). If the end-user installs the software, the contract starts from when the software is delivered (delivery note date).
- A maintenance contract can only be signed for the current version. Completion of a maintenance contract only covers the current version. If you decide to take out a maintenance contract after purchasing the software it may first be necessary to update your existing version. The value of the software licence obtained is calculated based on the current valid price list.
- Payment is due for twelve months in advance.
- Both parties can cancel the contract three months before the end of the contract.
- The contract is valid for twelve months and is automatically extended if not cancelled in good time.

## **6 Update**

An update for **infra - CONVERT** can also be purchased without a maintenance contract. The cost of the update is calculated for every full month between the date of purchase of the software and the purchase of the update at 2 % of the licence price. Updates are not available 24 months after purchase of the software.

## **7 Expansion**

Expanding an existing **infra - CONVERT** licence to include further licences or modules is only possible with the latest software version. If no maintenance contract exists, an update has to be bought, if necessary.

If a maintenance contract exists, the additions are automatically incorporated into the maintenance contract and the fees adjusted accordingly. Additional modules are purchasable at any time for the prices listed below. For floating licences all installations need to have the same modules.

For additional licences the difference to already purchased licences will be billed. Therefore, the prices of the already purchased licences will be determined with the current price list at that time.
